Employee furlough deadline and government updates

Short regular briefing from Community Impact Bucks

We would like to bring your attention to the imminent deadline (10th June) to furlough staff who have not yet been furloughed – details are outlined below.

For those organisations which are planning to reintroduce pre-lockdown operations, you will find links to the Government's updated advice below plus guidance from the Charity Retail Association for charities looking to reopen their shops from the 15th June.

Short notice announcement: if you are re-opening your facilities, the Cranfield Trust is running a webinar today (Thursday 4th at 11am) which will look at areas that you will need to consider when staff are returning to the usual place of work – for more information, visit A practical guide to re-opening after COVID closedown webinar.

LAST CHANCE TO FURLOUGH AN EMPLOYEE: 10 JUNE

You have just six days to furlough any employees who haven't yet been furloughed (deadline of 10 June) (reference NCVO).

From 1 July, employers can bring back to work employees that have previously been furloughed while still being able to claim CJRS grant for their normal hours not worked. When claiming the CJRS grant for furloughed hours, employers will need to report and claim for a minimum period of a week.

The scheme is closing to new entrants from 30 June. After the 30th, employers will only be able to furlough employees that they have furloughed for a full three week period prior to 30 June. This means that the final date by which an employer can furlough an employee for the first time will be 10 June, taking into account the three week period prior to 30 June.
